INTERIM ORDER

1. The matter was heard on 25/06/2019 as scheduled. Representatives of both parties were present during the hearing.

2. Sh. Kuldeep Kumar Kohli appeared for the Petitioner and handed over various documents, as directed in the Interim Order dated 19/06/2019, to the Respondent.
3. On enquiry from the Commission related to the compliance of the direction as mandated in the Interim Order dated 19/06/2019, for submission of revised affidavit of Sh. Vijay Pal Malik, Secretary Ansals Aravali Retreat, Village Raisina (ARRWA), the Ld. Counsel submitted that they are yet to comply with the same.
4. Similarly, the Commission inquired from the Respondent the compliance of the directions mandated in the Interim Order dated 19/06/2019, the Ld. Counsel submitted that they require around 1 (month) time period for the same.
5. The Ld. Counsel on behalf of the Petitioner submitted that as requested during early hearings, the Commission may direct the Respondent to maintain the electricity network as they are ready to provide the maintenance cost.
6. The Commission heard the parties and, accordingly, directs them to comply with all the directions of the Commission issued in previous Interim Orders including submission of revised affidavit of ARRWA, chronology of conversion from original electrification plan to as on date, reasons for providing commercial connections when original electrification plan did not have any commercial establishment, total load as on date, reasons of not taking over & maintaining the electrical infrastructure up to the meter, list of all connections provided to the consumers in the Petitioner's area date wise from first to last connection along with names of officers/officials who provided such connections and submit their report within 1 (month) from the issuance of this Order.
7. Further, taking into account the larger interest of consumers, the Commission directs Respondent i.e., DHBVN to carry out day to day maintenance and cost arises, if any on account of such maintenance shall be admittedly provided by the Petitioner to the Respondent.
