### **INTERIM ORDER**

1. The case was heard on 03/02/2026, as scheduled, in the court room of the Commission.
2. To the query of the Commission, counsel for the respondents-DHBVN submitted that the XEN is unable to attend the Court due to shoulder surgery.
3. The Commission noted with concern that no exemption has been sought by the XEN. The case pertain to non-compliance of CGRF order and XEN is violating even the orders of the Commission. Thus, decides to impose cost of Rs. 25,000/- and issue show cause notice under section 142 of the Electricity Act, 2003.
4. Ms. Aerika Singh counsel for petitioner, requested for 3 weeks' time to file the reply.
5. The Commission adjourns the matter and directs the concerned SDO and XEN as well as President and Secretary RWA to be present in the court on next hearing. The respondents to submit their replies with in two (2) weeks and the petitioner may submit its rejoinder, if any, within one week thereafter with advance copies to each other.
6. The matter to come up next on 05/03/2026.
