## ORDER

A. Shri Mahipal Singh has filed an appeal through Shri Ashwani Kumar Singla, Advocate against the order dated 14.10.2022 passed by CGRF DHBVNL in case No. 3878 of 2021. The appellant request for following relief as under: -

1. To order CGRF Gurugram to carry out necessary correction and / or issued additional certificate enabling the appellants to file appeal, containing the names of all the petitioners and respondents / defendants before it.

- 2. Any other relief, which this Hon'ble Ombudsman feel necessary and in favour of the appellants, on the merits of the case.
- **B.** The appeal was registered on 18.10.2023 as an appeal No. 88/2023 and accordingly, notice of motion to the Appellant and the Respondents was issued for hearing the matter on 31.10.2023.

**C.** The respondent SDO vide email dated 23.10.2023 has submitted reply which is as under: -

In reference of your good office memo no. EO/HERC/Appeal No. 88/2023/3101-07 dated 18.10.2023, regarding to subject cited appeal. it is submitted that after going through the petition, it is found that the petitioner wants to review the order passed by Hon'ble CGRF, so in this matter SDO 'OP' S/Divn., DHBVN, Manesar have no jurisdiction. It is therefore requested to review / reconsider the petition and take necessary action accordingly.

**D.** Hearing was held today, as scheduled. Both the parties were present during the hearing through video conferencing. At the outset, the counsel for the appellant submitted that the name of all the complainant and respondents have not been mentioned in the CGRF order dated 14.10.2022 due to which they are unable to file appeal. The appellants prayed that order CGRF Gurugram to carry out necessary correction and / or issued additional certificate enabling the appellants to file appeal, containing the names of all the petitioners and respondents / defendants before it.

The respondent SDO submitted that he has no objection.

E. In view of the above facts and circumstances, the matter is remanded back to the CGRF, DHBVN for deciding the prayer of the complainant on factual basis. The appeal is disposed off accordingly.
