2. 1 (1) These Regulations may be called the “Haryana Electricity Regulatory Commission (Conditions of Transmission Licence) Regulations, 2008, 2nd Amendment Regulations, 2021” instead of “Haryana Electricity Regulatory Commission (Conditions of Transmission Licence) Regulations, 2008, 1st Amendment Regulations, 2021”.

Notification

Regulation No. HERC/18/2008/1st Amendment/2021:- In exercise of the powers conferred on it by section 16 read with section 181 of the Electricity Act 2003 (ACT 36 of 2003) and all other powers enabling it in this behalf and after previous publication, the Haryana Electricity Regulatory Commission makes the following amendment to the Haryana Electricity Regulatory Commission (Conditions of Transmission Licence) Regulations, 2008 as under:-

1. Short title, commencement, and interpretation.

- (1) These Regulations may be called the Haryana Electricity Regulatory Commission (Conditions of Transmission Licence) Regulations, 2008, 1st Amendment Regulations, 2021.
- (2) These Regulations shall come into force on the date of their publication in the Haryana Government Gazette.
- (3) These Regulations shall extend to whole of the State of Haryana.
- (4) These regulations shall apply to the licence issued for Transmission of Electricity under section 14 of the Act; in accordance with HERC (Transmission & Distribution Licensing) Regulation No. HERC/09/2004 as well as to the deemed licensee.

2. Amendment to Regulation 6- Prohibited Activities

Insertion of a new clause (e) under Regulation 6.1:

6.1 (e) Shall not transfer the "controlling interest" in their share capital to any other entity without specific approval of the Commission.

Provided, the Licensee shall furnish all the relevant details/documents to the Commission for the intended transfer of the equity share along with requisite fee as per Haryana Electricity Regulatory Commission (Fee) Regulations, 2005, amended from time to time.
