Regulation No. HERC/04/2004/1st Amendment, 2007: - In exercise of the power conferred on it by Section 181 of the Electricity Act, 2003 (36 of 2003) and all other powers enabling in this behalf and after previous publication, the Haryana Electricity Regulatory Commission, hereby makes the following regulation to amend the Haryana Electricity Regulation Commission (Standards of Performance for the Distribution Licensee) Regulation, 2004 hereinafter referred to as "the principal regulations" namely:-

- 1. Short title, Commencement and Interpretation
 - These Regulations may be called the Haryana Electricity Regulatory Commission (Standards of Performance for the Distribution Licensee) 1st Amendment, Regulation, 2007
 - (ii) These regulations shall be applicable to all distribution & retail supply Licensees in their respective areas of licensed jurisdiction.
 - (iii) These regulations shall extend to whole of the State of Haryana.
 - (iv) These Regulations shall come into force on the date of its publication in the Haryana Government Gazette.
 - (v) The Punjab General Clauses Act 1898 (Act 1 of 1898), as applicable to the State of Haryana shall apply qua the interpretation of these regulations.

2. Amendment to Schedule I, II and III of the Regulation.
