- 3) The Ld. Counsel appeared on behalf of Respondent No.2 and submitted that he has only received summon but not the copy of the Petition. Accordingly, the Petitioner was directed to furnish a copy of the Petition to the Respondent which has been provided by the Petitioner.
- 4) The SDO Op., S/D City, Ganour submitted that Respondent No. 1 has been provided Non-Domestic Supply connection and no individual connections have been sanctioned, inspite of request received from the Petitioners, as the electrical infrastructure is yet to be completed by the Respondent No. 1.
- 5) The ATP, Sonipat also submitted that he had not received the copy of the Petition which has been provided by the Petitioner now. The Commission directs him to remain present on the next date of hearing with the relevant information/documents.
- 6) The Commission directs Respondent No.2 to clarify the following on the next date of hearing: -
  - a) Whether completion certificate has been obtained from Director, Town and Country Planning Department ?
  - b) Whether Single point Connection has been applied/obtained for the supply to the Petitioners ?
  - c) Under what Provisions/Rules electricity connections have been provided to the individuals and electricity Meters have been installed?
- 7) On request of the Ld. Counsel of Respondent No.2, the next date of hearing in the matter is fixed on 17/12/2019 at 11:30 A.M. The Respondent No. 3 is exempted to appear on next date of hearing.
