**Regulation No. HERC/08/2004-Amendment, 2017.**— In exercise of the power conferred by Sub – section (1) of Section 181 of the Electricity Act, 2003, the Haryana Electricity Regulatory Commission hereby makes the following Regulations to amend the Haryana Electricity Regulatory Commission (Terms & Conditions of service of the Electricity Ombudsman and the Officers and the Staff of the office of the Electricity Ombudsman) Regulations, 2004 namely:-

1. (i) These Regulation may be called the Haryana Electricity Regulatory Commission (Terms & Conditions of service of the Electricity Ombudsman and the Officers and the Staff of the office of the Electricity Ombudsman) Amendment Regulations, 2017.
- (ii) They shall be deemed to have come in to force on the 1st day of January, 2016.
2. In the Haryana Electricity Regulatory Commission (Terms and conditions of Services the Electricity Ombudsman and the Officers and the Staff of the office of the Electricity Ombudsman) Regulations, 2004, the following shall be substituted:-

**3.1 The Electricity Ombudsman**

- (a) The Electricity Ombudsman shall be in the pay matrix 20 carrying pay scale of Rs.1,82,200-2,24,100 per month subject to deduction of the gross amount of Pension including any commuted portion thereof if already getting.

**3.2 The Officers and staff of the office of the Electricity Ombudsman**

The existing schedule-I under regulations 3.2 (a) shall be as under:-

- (i) If the staff is taken from the power utilities/other services/organization on deputation their pay scale can be fixed at their own pay scales.
  - (ii) The fixation of Pay in the revised pay structure and other related matters will be in accordance with the provisions contained in the Haryana Civil Services (Revised Pay) Rules, 2016 issued vide Notification No.1/20/2016 (RP)-5 PR (FD) dated 28th October, 2016 and instructions issued vide letter No.1/20/2016 (RP)-5PR (FD) dated 15th November, 2016 and as amended/modified from time to time.
  - (iii) These amendments are being made on the basis of approval of the State Government conveyed vide their Memo No. 2/13/2009-1 Power dated 19.04.2017.
